## Rio Favorable To Heights Water

### ALPINE DISTRICT PRESENTED WITH RESTRAINING COURT ORDER

The regular meeting of the Alpine Heights Municipal Water District on Wednesday evening was abruptly interrupted immediately after the roll call when Mrs. Edith Bishop of Harbison Canyon addressed the Board of Directors saying, "I have another present for you boys."

Mrs. Bishop promptly presented each of the directors with a temporary restraining court order which had been filed by George Butcher and Raymond W. Scruggs. Butcher and Scruggs are committeemen representing the proposed East County District.

The action came as a complete surprise to the Alpine district Board of Directors and Alpine residents who had gathered for the routine meeting. The agenda was to include a report from Mr. Eugene Freeland, manager of the Alpine district, giving the results of a survey on the prospects of obtaining water and a hearing on the annexation of 15 parcels of land to the Alpine district.

John Gregory, attorney for the Alpine water district, stated that he had no prior knowledge of the existence of the restraining order and indicated that the procedure was quite irregular.

Eleven persons wishing to annex to the Alpine Heights District were present at the meeting. Practically all expressed extreme indignation regarding the action of the East County proponents in disrupting the immediate business and regular procedure of the Alpine district. The meeting was temporarily adjourned while an informal conference was held to

### **Brush Fire Burns** 12 Acres In Canyon

A fire broke out last Sunday at about 5:30 p.m. in the Harbison Canyon area south of Chocolate Drop Mountain burning off approximately 12 acres of brush land. No residential damage was

The Harbison Canyon Volunteer scene and stood by to protect residences from any possible fire damage.

Fifteen trucks from the State Division of Forestry had been employed in the fight before the fire was brought under control two hours later. The steepness of the terrain made it impossible for the trucks to gain access to the fire and under the supervision of the State Division of Forestry, it was necessary to use bulldozers and residents, these crews included fighters from Alpine, Suncrest, Minniwawa and Veijas Honor Camp. ### East County Must Form District Before Asking Annexations

The Water Problems Committee of the San Diego County Water Authority gave considerable time to the proposed East County Water District at a meeting in San Diego on September 10.

A large map, displayed at the front of the room, was represented as the East county area. Most of the map was colored bright green, this color designating the East County section, with very much smaller squares inked in red said to represent the Alpine Heights Municipal Water District and those wishing annexation to the latter.

A spokesman from Dehesa, Mr. Loren Howard, rose and stated calmly that he and others in his area, wished exclusion from East County plans, not wishing to be (quote) "swallowed up by a monster." Mr. Bawer of Lawson Valley, rose and stated that the map was not correct since he and his neighbors were marked in it and did not wish to be included in the proposed boundaries of the proposed East County district, and had not been informed or consulted about it in any way.

Another group requested by petition, to be annexed to the East County plan. But in discussing the issue, Mr. William Jennings, attorney for the Water Authority, stated, "There is no point in debating the pros and cons of a proposed annexation to a proposed district." He said the first thing that must be done was for the district to be formed. "We are wasting our time and beating our gums," he said, "considering

### **Editorial Echoes**

Since formation of the Alpine Heights Municipal Water District the tactics of the members of the proposed East County District appear to have been those principally of harassment. The East County group has seemingly become more interested in heckling and disrupting the orderly progress of the Alpine Heights District rather than attempting to demonstrate any additional evidence that they have a workable plan for the formation of a water district.

A recent public meeting called by the East County group revealed no significant new facts which might influence local opinion and when questions from the floor were abruptly terminated, most Alpine residents were disgruntled and remained highly skeptical of the intentions of the East County-proposal.

The attitude of the Alpine Heights District has been largely to ignore the East County activities and proceed in an orderly manner with the business and function of a water district.

One recent legal action has been dismissed. Now another suit has been strategically filed to surprise the Alpine Heights Board of Directors at a regular meeting which delays and interferes directly with the conduct of the affairs of the district.

Many "Alpiners for Alpine" are furious.

### A LETTER FROM ABROAD

From Mrs. J. L. Isaacs (Betty Moore, Daughter of the Roger Moores of Alpine)

> Wiesbaden, Germany August, 1959

A few weeks ago I started a short piece for the "Echo" on my attempts at preparing sauerbraten the German method. I had the recipe and everything to send along, but now I wouldn't dare! I kept the meat in a covered dish (as the directions said) turning it religiously every day and I must have put in too much or too many spices for around the fourth day it began to have a most suspicious odor. I thought nothing of it, not knowing much about sauerbraten, and, in my excitement over creating 'such a "dish," I invited friends in to share it with us. To make a most embarrassing story short, at the end of the meal there was much sauerbraten untouched and no remains of the apple pie, cheeses and wine. I really think maybe seven days is too long. Our son Michael Jon had his

first birthday last Friday and has been walking now for two weeks. With him into everything and anything, my days are busier than ever before. I do have three piano students each week and that is about the extent of my music these days. While in France, I had the finest piano teacher I think there is. She herself was leave. a pupil of the famous Phillipe who in turn was a student of Chopin. She has marked my Chopin books just as he wished them played and I know I would not have received anything like that with all the teachers I could have had in the States. I did attempt to study here in Wiesbaden but the nature of the teacher was so arrogant and so in contrast with Mlle Chenaud (a maiden lady of 75) that I just could not continue with him. I think I'll always find other teachers lacking from now on because of Mlle. Chenaud.

In May, Jack and I took a boat trip up the Rhine. We left at 1:30 in the afternoon and leisurely sailed up as far as the legendary Lorelei Rock. How beautiful it was. The rock, or mountain, extends out on a very wide curve in the river surrounded by dark green mountains dotted here and there with old castles. I could almost picture the lovely Lorelei standing on top of the rock beckoning the sailors of the river. The Rhine has quite a lot of traffic, much more than any of the Seine we saw. Mostly long barges with a few sailing boats and more pleasure vessels. It is very beautiful and no wonder that all the boats are filled to capacity. The one we were on was chartered by the Masons with only around 150

It was reiterated that East County proponents were helpless to do anything about accepting annexations or anything about water until they are a formed district with a legal status as such. This forming of districts, Mr. Jennings pointed out, is not within the jurisdiction of the Water Problems Committee, or Water Authority at all, but rests with the Board of Supervisors to approve the appeal to form a district after which a duly called election must be held to determine the people's will in the matter. "We cannot accept them until we know whether they will be formed or not," the attorney explained. Mr. Phelps said, when asked, that he had filed the petition with the Board of Supervisors last week on September 3.

Meanwhile, the attorney stated, any other area is free to seek annexation to any existing district. The way this is done is for the area wanting water to appeal to a formed district through its Board of Directors. Then if the existing water district accepts the new area, the water district officials, not the annexing area, appeals to the Water Authority.


