#### James Henry McKie

Services for J.H. McKie, who would have been 93 on April 9, were conducted at Goodbody's Chapel Monday. He died in a hospital Friday, where he was taken from his home, 1245 W. Victoria, by his son J.H. McKie, jr., local realtor.

McKie had lived in the county for 71 years. He was born in England while his parents were on a tour. He was graduated from Chicago College of Pharmacy. He started the first drugstore in La Jolla 55 years

Later he sold, went into the realty business with Barney, McKie & Rife, who subdivided and developed areas in Mission and Ocean Beaches. His father 75 years ago purchased the NE corner of Fifth & Broadway for \$5,000. from Alonzo "Father" Horton, erected what was known as the McKie Building. After his father died he leased the property to the First National Bank. In later years the land was sold.

McKie retired from real estate ih 1941 after having spent 50 active years in it. He had lived here 10 years with his son and was active and alert to the end. He was a member of Elks Lodge 168 of SD for 35 years.

The feeble rainfall deepened at high costs. Today no man with a good well can be assured flat tomorrow he will not have to spend a lot to keep abreast of the water table.

Water here comes from higher levels where snow and rain supply runoff that goes into the ground, trickles downward. This year for example, the Cuyamaca reservoir ís dry for the first time in 60 years! Probably it is the first time since its completion in 1887. At that point normal rainfall is 24.56 inches, but this year's is a méagre 7.57, only about one third.

On March 21 Alpine and adjacent communities will vote on \$3 million bonds to bring water to these parched areas. It would seem that there is no valid reason not to give the vote a high percentage which will cut interest costs. our slogan is "Improve the value of your property with water".-CI

When we came here in Feb. 1949, our main well was 67 deep with 6' of water which could not be drained no matter how much we irrigated. This fine well supplied our home, and three houses next door, in addition to our 10-unit trailer park, plus an orchard.

Then the water table went down. We drilled to 245 ft. paid \$835. and got no water. Our other well went dry and it was deepened at a cost of But while it has held up fine, it is still going do wn 1

We have two other dry holes that cost hundreds of dollars and yield no water, therefore we want water and will be glad to pay connection charges and taxes to have the supply. We know dozens of others who are in the same fix.

Cost appears to be the main objection in bringing water to Alpine, but as a matter of record, my water bill for the past 20 years has totaled \$6,135. or \$25.56 per month. This cost includes drilling 2 wells, one of them a dry hole in a creek bed, pumping equipment and electricity. This was not for irrigation but for the barest essential amount.

If this season is an indication of what the future holds in respect to rainfall, many neighbors who now say they have plenty of water and are not interested, may soon regret not voting YES for WATER when they had the opportunity.

"Throughout 18 years of public life", Brown said, "I have had first hand knowledge that the free press can be and usually is a potent power for goodboth in government, and the private concerns of our citizens. As district attorney, as attorney general and as governor I have been a consistent-and insistent--defender of your right to report the facts and speak the truth as you see it.

"Politically, I must repeat something I have said many times. So great is the power of the press that newspapers should not speak for one party or the other. You must fight fiercely to retain your independence. In your own crusty, constructive way, you must continue to let both Republicans and Democrats know that you stand for the right, not the party".





Section 2. That, following a hearing thereon as by law provided, this Board has determined, and does hereby determine and state, that the portion of said district which will be benefited by the accomplishment of said purpose hereinabove stated and by incurring said bonded indebtedness constitutes and is known as "IMPROVEMENT DISTRICT NO. 1 OF RIO SAN DIEGO MUNICIPAL WATER DISTRICT" and that a map showing the exterior boundaries of said improvement district is on file with the secretary of said district, which map shall govern for all details as to the extent of the improvement district.

Section 3.
