SCME DON'T WANT TOWN N. OF FREE WAY.

On Nov. 19 supervisors are hearing pros and cons on a proposed new village north of US 8 near Tavern Road, on land that is lying idle. It is about 300 acres, of which the owners want rezoning for a shopping area of 20 acres, 18 for apartments, the remainder to be for 1-family dwellings.

They propose a major road from
Tavern northerly and easterly to connect with W. Victoria Dr. Also to put
in a connecting road from the new freeway access road north of the reservoir

to this new county road.

The subdivision would be connected to the sewer system and the Rio SD MWD. Already natural gas is being considered for Alpine, which could also serve this proposed modern com-

has outlined the project which "will be developed in the resemblance of a new city, planned so that residential lots will get full view of Alpine and the mountains to the east and west. As required by new county ordinances all wiring will be underground, and the streets will be according to county specifications.

Since the owners have paid taxes on the school district for several years, they are assured it will be within the local district. With about 720 lots in this area, and a possibility of 500 on adjacent ownerships, there could be some 5000 to 6000 new residents in the near future.

Thus it was because of this finding that it was determined 20 acres was necessary for a shopping center. This has been proven in many communities where new freeways were built, that many new residents need a large, new commercial area, for their proposal.

The planning office has turned down the first request for change from the agricultural zoning. Some here do not favor the development; others do, and may be heard next Tuesday when the supervisors convene. CI.





The Board of Directors of Rio San Diego Municipal Water District DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

Section 1. That this Board of Directors deems it necessary that the Rio San Diego Municipal Water District incur a bonded indebtedness by the issuance of bonds of the district for Improvement District No. 2 of Rio San Diego Municipal Water District in the amount of \$200,000 for the purpose of the acquisition, construction, completion and repair of a waterworks system, including reservoirs, pumping stations, transmission and distribution lines, conduits, pipelines, works, valves, meters, fittings, machinery and other property (including lands, easements, right and privileges), and including water rights and existing waterworks systems, useful or necessary to store, convey, supply or otherwise make use of water for the lands and inhabitants within the exterior boundaries of Improvement District No. 2 of Rio San Diego Municipal Water District, and all other property and expenses necessary for any of the foregoing including engineering, inspection, legal, and financial and consultant fees, costs of the formation of said improvement district, of the bond election and of the issuance of bonds, and all other costs and expenses incidental to or connected with the accomplishment of said purpose.

Section 2. That, following a hearing thereon as by law provided, this Board has determined, and does hereby determine and state, that the portion of said district which will be benefited by the accomplishment of said purpose hereinabove stated and by incurring said bonded indebtedness constitutes and is known as Improvement District No. 2 of Rio San Diego Municipal Water District, as set forth in Resolution No. 371 , the resolution of formation of said improvement district, and that a map showing the exterior boundaries of said improvement district is on file with the Secretary of said district, which map shall govern for all details as to the extent of the improvement district.

Section 3. That the maximum term which the bonds proposed to be issued, or any portion or series thereof, shall run before maturity shall not exceed the maximum term permitted by law, to wit, forty (40) years from the date of said bonds or each series thereof, but said bonds may be made to mature within a lesser number of years; that the maximum rate of interest to be paid thereon shall not exceed the maximum rate permitted by law, to wit, six and one-half percent (6-1/2%) per annum, payable semiannually, except that interest for the first year may be pavable at the end of said year, the actual rate or rates to be determined at the time of the sale or sales thereof.

Section 4. That a special election be held, and the same is hereby called to be held, in said Improvement District

No. 2 of Rio San Diego Municipal Water District on Tuesday, the 10th day of December, 1968, for the purpose of submitting to the qualified voters of said improvement district the proposition of incurring said indebtedness and issuing bonds of said district for said improvement district, in the amount hereinabove set forth, and for the purpose hereinabove stated.

That if the proposition for the incurring of said indebtedness so submitted receives the requisite number of votes in favor of and assenting to the incurring of the indebtedness, to wit, more than two-thirds of the votes of the qualified voters voting at such election, bonds of said district for said improvement district in not exceeding the principal amount hereinabove stated shall be issued and sold, at such time or times as the Board of Directors of Rio San Diego Municipal Water District deems proper, for the purpose hereinabove set forth. That if the proposition for the incurring of bonded indebtedness so submitted receives the requisite number of votes, to wit, more than two-thirds of the votes of the qualified electors voting on said proposition, bonds of said improvement district, in an amount not exceeding the principal amounts stated in such proposition, may be issued and sold, at such time or times as the Board of Directors of Rio San Diego Municipal Water District deems proper, for the object and purpose set forth in said proposition.
