EDITORIAL

ARE MAN'S DIRTY HABITS KILLING US ALL?

Nearly every day news papers or radio tell of the imminent dangers of air pollution. Water and land poisoning are also mentioned, water from all sorts of industrial wastes and chemicals, land from the same plus pesticides. The outlook is frightening, say scientists.

Since the start of nuclear testing in 1951, a radiation physicist claims, 25% more infants die in America due to

fall out. Dr. E. J. Sternglass of the U of Pittsburgh, says a small atomic war could end mankind! But the 34,000 baby deaths a year has dropped since the signing of the test ban treaty.

In Chicago air pollution is blamed for asthma and other respiratory increases, also in Tokyo, and in New Orleans. An Italian researcher says that such ailments among children 7 to 12, is proportional to the degree of smog existing. Pollution decreases lung activity which is necessary for health.

In LA researchers found that smog is composed of carbon from gasoline, asphalt from pavement, dust from asbestos brakebands and powdered auto tires, and gasses from motor fuels including dangerous lead. The air can clean itself only by precipitation, but the poisons today are an overload.

In Detroit a meeting was told that cleaning up smog would reduce human miseries from colds from 10 to 20%. For 3 years a U of Washington in Seattle team studied this in NY City. Adverse weather added to the causes.

Only last week singer Frank Sinatra left "Smog" Angeles permanently for Palm Springs to preserve his throat, irritated by the smoke. He sold his 2 homes, and he is not the only one to leave that smog-ridden megalopolis. The Irvine family did in 1937, then permanently in 1949!

Yes man's survival is at stake; it is desperate. Or is the Biblical prediction coming true - "destruction by fire. . . in the last days". --CI.

Section 2. That, following a hearing thereon as by law ~~provided, this~~ Board has determined, and does hereby determine and state, that the portion of said district which will be benefited by the accomplishment of said purpose hereinabove stated and by incurring said bonded indebtedness constitutes and is known as Improvement District No. 2 of Rio San Diego Municipal Water District, as set forth in Resolution No. 371, the resolution of formation of said improvement district, and that a map showing the exterior boundaries of said improvement district is on file with the Secretary of said district, which map shall govern for all details as to the extent of the improvement district.

Section 3. That the maximum term which the bonds proposed to be ~~issued,~~ or any portion or series thereof, shall run before maturity shall not exceed the maximum term permitted by law, to wit, forty (40) years from the date of said bonds or each series thereof, but said bonds may be made to mature within a lesser number of years; that the maximum rate of interest to be paid thereon shall not exceed the maximum rate permitted by law, to wit, six and one-half percent (6-1/2%) per annum, payable semiannually, except that interest for the first year may be payable at the end of said year, the actual rate or rates to be determined at the time of the sale or sales thereof.

Section 4. That a special election be held, and the same is hereby called to be held, in said Improvement District

No. 2 of Rio San Diego Municipal Water District on Tuesday, the 10th day of December, 1968, for the purpose of submitting to the qualified voters of said improvement district the proposition of incurring said indebtedness and issuing bonds of said district for said improvement district, in the amount hereinabove set forth, and for the purpose hereinabove stated.

That if the proposition for the incurring of said indebtedness so submitted receives the requisite number of votes in favor of and assenting to the incurring of the indebtedness, to wit, more than two-thirds of the votes of the qualified voters voting at such election, bonds of said district for said improvement district in not exceeding the principal amount hereinabove stated shall be issued and sold, at such time or times as the Board of Directors of Rio San Diego Municipal Water District deems proper, for the purpose hereinabove set forth. Said bonds will be bonds of the district, but taxes for the payment of such bonds and the interest thereon shall be levied exclusively upon the taxable property within said Improvement District No. 2 of Rio San Diego Municipal Water District, all as provided in the Municipal Water District Law of 1911, as amended.

That the polls for said election shall be opened at 7 o'clock a.m. of the day of said election and shall remain open continuously from said time until 8 o'clock p.m. of the same day, when said polls shall be closed, except as provided in Section 14436 of the Elections Code of the State of California.

Section 6. That at said election the following bond proposition shall be submitted to the voters, and that on the ballots to be used at said election, in addition to any other matters required by law, there shall be printed substantially the following:

That if the proposition for the incurring of bonded indebtedness so submitted receives the requisite number of votes, to wit, more than two-thirds of the votes of the qualified electors voting on said proposition, bonds of said improvement district, in an amount not exceeding the principal amounts stated in such proposition, may be issued and sold, at such time or times as the Board of Directors of Rio San Diego Municipal Water District deems proper, for the object and purpose set forth in said proposition.

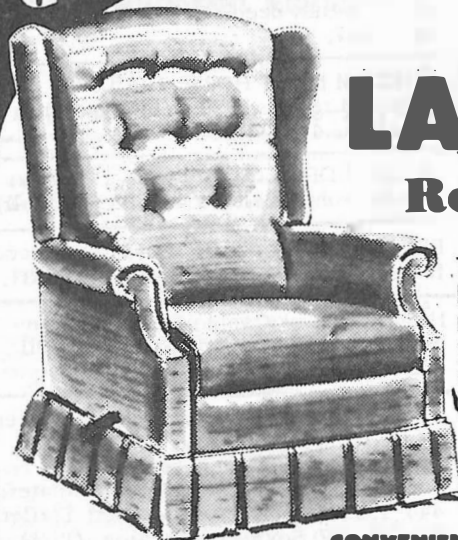
