




She does not. At a quarter after nine the phone rings.

Come to think of it, that might be a solution to my whole problem!



Social Security News

Many people are under the impression that all elderly persons in nursing homes on January 1 are eligible for benefits under Federal Medicare, "This is not true," said Arlyn B, Carr, San Diego Social Security District Manager,

Extended care benefits under this part of the medicare program, beginning January 1. 1967, are designed for persons who are 65 or over, whose health insurance card shows entitlement to hospital insurance benefits. In addition, the person must have been hospitalized for at least 3 days and discharged after June 30, 1966. He must have been admitted to extended care facilities on a physician's orders for treatment of the same illness which existed during his hospitalization and within 14 days of his discharge from the hospital.

The patient must need extended care treatment which is only furnished in certain types of nursing homes, institutions, or hospitals. Specific approval is necessary before a nursing home can become eligible to participate in this phase of the medicare program.

Extended care benefits under medicare are not payable to a person admitted to a nursing home or other facility for custodial or long-term personal care which is primarily for further treatment of the condition for which he was hospitalized.

Canned Pineapple Goes Upside Down

Topsy turvy pineapple cakes are miniature versions of the classic upside down dessert. To get the handsome glazed crown, put but-ter and brown sugar in the bottom of each foil pan along with a whole canned pineapple slice and walnuts. Some of the syrup drained from the pineapple goes into the batter to give a tropical flavor throughout. Garnished with whipped cream, these little pineapple favorites are perfect for the ladies bridge club.

INDIVIDUAL PINEAPPLE UPSIDE DOWN CAKES

- 1 (1-pound 14-ounce) can pineapple slices
- 1/2 cup butter
- 1 cup brown sugar (packed)
- 24 walnut halves
- 21/2 cups sifted cake flour
- 11/2 cups sugar

- 4 teaspoons baking powder 112 teaspoons salt
- 23 cup soft shortening
- 1/2 cup milk
- 1 teaspoon grated lemon peel 2 teaspoons vanilla
- 2 eggs

Drain pineapple, reserving ½ cup syrup. Spoon one tablespoon melted butter into each of 8 (5-inch) individual foil pans; sprinkle with brown sugar and top with drained pineapple slice. Arrange 3 walnut halves around edge. Place on baking sheet and bake in moderate oven (350 degrees F.) about 5 to 8 minutes. Meanwhile, resift flour with sugar, baking powder and salt. Add shortening, ½ cup reserved pineapple syrup, milk, lemon peel, vanilla and eggs. Beat on electric mixer 2 minutes. Spoon batter on top of pineapple. Return to oven and bake about 35 minutes until cake tests done. Turn upside down on cake rack; remove pans and allow cakes to cool. Garnish with whipped cream as desired. Makes 8 servings.
